<b>Existing Control Measures</b>
1. First Aid Measures -Ingestion Rinse mouth thoroughly with water. Give plenty of water to drink. Do not induce vomiting. Get medical attention if any discomfort continues. .
2. First Aid measures -Skin contact Wash skin thoroughly with soap and water. Remove contaminated clothing. Get medical attention if irritation persists after washing.
3. First Aid measures- Eye contact Rinse immediately with plenty of water. Continue to rinse for at least 15 minutes. Get medical attention if any discomfort continues.
4. Firefighting measures;Suitable extinguishing media The product is not flammable. Use fire-extinguishing media suitable for the surrounding fire.
5. Accidental release measures -Personal precautions Wear protective gloves, eye and face protection. Environmental precautions- Environmental precautions Do not discharge into drains or watercourses or onto the ground.
6. Methods for cleaning up Contain and absorb spillage with sand, earth or other non-combustible material. Collect and place in suitable waste disposal containers and seal securely.
7. Always Use In Well Ventilated Area
8. Precautions for safe handling- Wash at the end of each work shift and before eating, smoking and using the toilet
9. Exposure controls/Personal protection - Eye/face protection Eyewear complying with an approved standard should be worn if a risk assessment indicates eye contact is possible.
10. Hand protection Chemical-resistant, impervious gloves complying with an approved standard should be worn if a risk assessment indicates skin contact is possible
11. Conditions to avoid Avoid freezing. Avoid exposure to high temperatures or direct sunlight.

12. Disposal methods Collect and place in suitable waste disposal containers and seal securely. Dispose of waste product or used containers in accordance with local regulations Always return empty packaging to region and dispose of in Drum A
